STORAGE FEE WILL CONTINUE UNTIL VEHICLE IS READY TO BE SHIPPED. YOU HAVE 2 DAYS OF FREE STORAGE IF, AFTER THE 2 DAYS STORAGE FEE OF WILL COMMENSE UNTIL VEHICLE IS READY FOR SHIPMENT.**
